JOB DESCRIPTION

You will:

Develop and support relationships with key policy stakeholders

- monitor Parliamentary debates, written questions, speeches etc.
- help to produce oral and written briefings, background papers etc. for external use, including policy partners and journalists
- provide support in responding to public consultations, advising policymakers and working with national research and policy bodies as appropriate.
- manage our parliamentary affairs database.

Monitor policy and research

- monitor developments in drug policy through tracking news reports, outputs from relevant NGOs, think tanks etc.
- monitor and analyse new research findings (published research papers, key datasets etc.)
- provide summaries for internal and external use on developments in drug policy and policy evaluation.

Support public communications

- support the production of regular, public-facing research and policy updates for publication on our website, aimed at a general audience
- identify media opportunities and help develop campaign initiatives
- support the production of our blog posts
- assist in event organisation.

Additional requirements will include

- sharing learning with other staff, volunteers, activists and trustees
- attending meetings, events and conferences
- contributing towards other aspects of Transform's work as required, commensurate with the scale and general nature of the post.

Essential experience

- involvement in policy-oriented activities or advanced forms of policy analysis
- using or analysing advanced research materials (e.g. peer-reviewed journal publications, databases, statistical resources).

- production of, or substantial contribution to, written outputs (e.g. reports, briefing papers, academic publications)
- working directly with policymakers or policy-based organisations
- working in, or closely with, organisations whose activities touch on substance use.

Essential knowledge

- strong degree (2:1 or above) and / or higher degree in politics, policy studies, public health or other field with clear relevance to drug policy
- understanding of policy processes and Parliamentary politics in particular
- awareness of how social inequality, cultural diversity and regional variation affect the social policy landscape.

Desirable Knowledge

knowledge of the drug policy, substance use, public health or mental health fields.

- ability to produce well-written reports, summaries and commentary on complex issues
- strong organisational skills and an ability to work on multiple projects simultaneously, prioritise workloads and meet deadlines
